कुठिला झील आर्द्रभूमि, जिला-फर्रुखाबाद और इसके प्रभाव क्षेत्र में प्रतिषिद्ध और विनियमित क्रियाकलापों का विवरण

प्रतिषिद्ध क्रियाकलाप -

- 1- किसी भी प्रकार के अतिक्रमण सहित गैर-आर्द्रभूमि उपयोगों के लिए संपरिवर्तन।
- 2- नए उद्योगों की स्थापना-विद्यमान उद्योगों का विस्तार।
- 3- परिसंकटमय पदार्थों/निर्माण और विध्वंस अपशिष्ट का विनिर्माण, प्रबंधन, भंडारण और निपटान।
- 4- जेस अपशिष्ट पाटन।
- 5- अशोधित मलजल/औद्योगिक बहिःस्राव/अपशिष्ट जल के लिए निमग्न।
- 6- निर्माण क्रियाकलाप (नाव घाटों को छोड़कर)।
- 7- प्लास्टिक, पॉलीथीन और अन्य गैर-जैव-अपघटनीय अपशिष्ट प्रदूषण।

विनियमित क्रियाकलाप-

- 1- जल निष्कासन/अवरोध/मोड़ या कोई अन्य जल विज्ञान हस्तक्षेप।
- 2- संसाधनों (जीवित/अजीवित) की कटाई।
- 3- चराई।
- 4- नाव घाट का निर्माण और अस्थाई उपयोग के लिये सुविधाएं, जैसे कि पीपापुल।
- 5- आर्द्रभूमि सीमाओं के भीतर जलीय कृषि क्रियाकलाप।
- 6- उत्तर प्रदेश नगर योजना और विकास अधिनियम, 1973 के अधीन तैयार प्रचलित महायोजना के अधीन प्रस्तावित सड़क तथा केंद्रीय सरकार, राज्य सरकार एवं उनके द्वारा गठित प्राधिकरणों/स्थानीय निकायों के अधीन निर्माण क्रियाकलापों सहित परियोजना।

- 7- आर्द्रभूमि पारिस्थितिकी तंत्र पर प्रतिकूल प्रभाव डालने वाले समस्त क्रियाकलाप।

नोट: इस अधिसूचना के सरकारी गजट में प्रकाशन से पूर्व किये गये निर्माण पर कोई प्रतिकूल प्रभाव नहीं पड़ेगा।

आर्द्रभूमि के भीतर तथा इसके प्रभाव क्षेत्र के भीतर विनियमित क्रियाकलापों की अनुज्ञा जब कभी अपेक्षित हो उत्तर प्रदेश राज्य आर्द्रभूमि प्राधिकरण द्वारा जिला आर्द्रभूमि समिति की संस्तुति पर दी जा सकेगी।

IN pursuance of provisions of clause (3) of Article 348 of the Constitution, the Governor is pleased to order the publication of the following English translation of notification no. 1115/LXXXI-4-2026 dated June 2, 2026:

No. 1115/LXXXI-4-2026

Dated Lucknow, June 2, 2026

WHEREAS there exists a water body known as "Kuthila Jheel" measuring an area of 4.3260 hectares situated in Tehsil Amritpur, District Farrukhabad, detailed description whereof is given in the Schedules below, which is considered to be critically significant for its ecosystem services and biodiversity values for the local communities and society at large;

AND WHEREAS, the aforesaid water body is a part of our cultural heritage; provides a wide range of ecosystem services such as water storage, water purification, flood mitigation, erosion control, aquifer recharge, micro-climate regulation, aesthetic enhancement of landscapes; and is important for environmental conservation, enrichment and development of adequate flora and fauna, ecology, landscape and humanitarian values;

AND WHEREAS, draft notification declaring the aforesaid water body as a "wetland" was published *vide* Government notification no. 648/81-4-2026 dated April 2, 2026 as required under sub-rule (3) of Rule 7 of the Wetlands (Conservation and Management) Rules, 2017 (hereinafter referred to as the "said rules"), for the information of the general public and with a view of inviting objections in respect thereof within 60 days from the date of publication of the said notification in the Official *Gazette*:

AND WHEREAS, no objection, in respect of the aforesaid draft notification, has been received within the stipulated period;

AND WHEREAS, considering the extent of ecological and biological diversity of "Kuthila Jheel" situated in District Farrukhabad, it is necessary to make the ecological character and ecological importance thereof enduring and it is also necessary to regulate the developmental activities in "Kuthila Jheel" and its Zone of Influence for the benefit of local communities and society at large;

NOW, THEREFORE, in exercise of the powers under sub-rule (3) of Rule 7 of the said rules, the Governor, with effect from the date of publication of this notification in the Official *Gazette*, is pleased to declare the area of "Kuthila Jheel", detailed description whereof is given in the Schedules below, as wetland which will now onwards be known as "**Kuthila Jheel Wetland**", District Farrukhabad.

The boundary and description of the area included under the Kuthila Jheel Wetland is mentioned in Schedule-I of this notification.

Details of the zone of influence (ZOI) of the Kuthila Jheel Wetland are mentioned in Schedule-II of this notification.

Description of prohibited and regulated activities in Kuthila Jheel Wetland and its zone of influence are mentioned in Schedule-III of this notification.

Description of permitted activities in Kuthila Jheel Wetland and its zone of influence are mentioned in Schedule-IV of this notification.

The source of water in Kuthila Jheel Wetland are rain water and underground water.

SCHEDULE-III

Description of prohibited and regulated activities in Kuthila Jheel Wetland, District Farrukhabad and its Zone of Influence

Prohibited activities-

- 1- Conversion for non-wetland uses including encroachment of any kind.
- 2- Setting up new industries / expansion of existing industries.
- 3- Manufacturing, handling, storage and disposal of hazardous substance / construction and demolition waste.
- 4- Solid waste dumping.
- 5- Sink for untreated sewage / industrial effluent / waste water.
- 6- Construction activities (except boat jetties).
- 7- Plastic, polythene and other non bio-degradable waste pollution.

Regulated activities-

- 1- Withdrawal of water / impoundment / diversion or any other hydrological intervention.
- 2- Harvesting of resources (living/non-living).
- 3- Grazing.
- 4- Construction of boat jetties and facilities for temporary use, such as pontoon bridges.
- 5- Aquaculture activities within the Wetland boundaries.
- 6- Road proposed under prevalent master plan prepared under the Uttar Pradesh Urban Planning and Development Act, 1973 and project including construction activities under Central Government, State Government and Authorities/ Local bodies constituted by them.
- 7- All activities having adverse effect on the wetland ecosystem.

Note: There will be no adverse effect on construction done before publication of this notification in the Official Gazette.

Permission for regulated activities within the wetland and within its Zone of Influence may be granted by the Uttar Pradesh State Wetland Authority on the recommendation of District Wetland Committee as and when required.

SCHEDULE-IV

Description of permitted activities in Kuthila Jheel Wetland, District Farrukhabad and its Zone of Influence

All activities, except those described in Schedule-III, which are not in contravention of the Wetlands (Conservation and Management) Rules, 2017.
