Submission of Monthly Progress Report for the month of **SEPTEMBER 2024** in the NGT  
Matter OA No. 673 of 2018 (in compliance to NGT order dated 24.09.2020)  
For the State/ UT of **Andaman& Nicobar Islands**

**I. Overall status of the State:**

- **Total Population:**

Sri Vijaya Puram City (Current estimated)– 1,48,062 (1,08,058 as per Census 2011),

Rural population – 2,19,535.

- **Total consumption of water:**

Total consumption of water at Sri Vijaya Puram City: 29.50 MLD (households, shipping industries, airports, agricultural lands, fisheries, parks & green area, government institutions, industrial clusters and swimming pools, etc.)

Total consumption of water in rural area: 12.07 MLD

Quantity of sewage generated at Sri Vijaya Puram City = 23.60 MLD

Quantity of sewage generated at rural area= 9.656MLD

II. **Estimated Sewage Generation (MLD) in ANI:** 23.6 MLD + 9.656 MLD = 33.256 MLD

III. **Details of Sewage Treatment Plant:**

- **Existing No. of STPs and Treatment Capacity (in MLD):**

17. 139 STPs of Hotel Industry (Total capacity) = 2.303MLD

18. Sewage generated treated through pre-captive  
Treatment through septic tanks = 17.436MLD

- **Gap in sewage treatment = 13.517MLD**

\*(Based on the empirical formula)

- **MLD of sewage being treated through Alternate technology:** On-site Septic Tanks catering to 100% Households for dispersion.

- **Future proposal for reducing the gap in treatment capacity:**

1. Work order for 01 decentralized STPs of capacity 10.00 MLD has been awarded and work is under process and will be completed by 30<sup>th</sup>October, 2024. However, the project has encountered delays due to vendor- related issues and local climatic conditions. **Project is re-examined and rejected.**

2. DPR for establishing STPs for treating 18.24 MLD sewage considering the future operation of international Airport and fast development of tourism is under preparation and shall be executed under Smart City Mission and other Schemes/Plan Heads. The work was expected to be completed by 2025-26. **Project is re-examined and rejected.**

\*\*\***(Projects are re-examined-Sri Vijaya Puram Municipal Council had conducted a comprehensive analysis of 20 major drain outfalls in May 2024, during the peak dry season by NIOT. SVPMC has received a project proposal from IIT Bombay for wastewater remediation in all drains. The IIT Bombay team visited ANI and conducted a detailed survey to propose suitable treatment mechanisms.)**

To address the gap of 13.517 MLD (considering 02.303 MLD capacity sewage treatment plants are available with private units) and to cater to future needs, a **25 MLD in-situ end treatment wetland technology by phytoremediation across 20 major drains** to cover the whole city of Sri Vijaya Puram is proposed & approved at a cost of Rs. 39.20Cr. (with funds identified under smart city program), tenders for all the drains have been floated. These projects are identified instead of the earlier construction of STP under smart city project. (Details of the project is enclosed as **Annexure-I**)

\*To assess the environmental impact of waste water discharge, **SVPMC conducted a comprehensive analysis of 20 major drain outfalls in May 2024**, during the peak dry season. Testing was carried out by the National institute of Ocean Technology (NIOT) and the results revealed that Biochemical Oxygen Demand (**BOD**) **levels in the drains were well within the permissible limit(<30 mg/L)** as stipulated in Schedule-VI of the Environment (Protection) Rules, 1986.

**\*An analysis of major drain outfalls in Rural Area is to be conducted by RD&P** through National institute of Ocean Technology (NIOT).(Analysis Report is enclosed as **Annexure-II**)

#### V. **Solid Waste Management:**

- **Total number of Local Bodies and their Population:**  
1 ULB namely Sri Vijaya Puram Municipal Council with population of 1,08,058 (Census 2011) and current estimated to 1,48,062 in Sri Vijaya Puram City.  
70 Gram Panchayats with population of 2,19,535 in rural area.
- **Current Solid Waste Generation:**  
Sri Vijaya Puram city = 66.16 TPD  
Rural area = 10.98 TPD
- **Number, installed capacity and utilization of existing MSW processing facilities in TPD:** (bifurcated by type of processing eg- Waste to Energy (Tonnage and Power Output), Compost Plants (Windrow, Vermi, decentralized pit composting), bimethanation, MRF etc:
  1. For the dry waste management in urban area, **18 Dry Resource Centers (DRC)& Material recovery Facilities (MRFs)** are setup, mostly operated by Private players (authorized dealers) collect the dry waste from designated wards for segregation, bailing and transportation of waste to mainland by for scientific disposal/recycling of waste at mainland.
  2. For the wet waste management in Urban area, **11 wet waste processing facilities** have been setup and operational, comprises of pit composting facility at Brookshabad, Gandhi Park, Anarkali-1, Brichgunj & bin composting at Junglighat. Also windrow compost units at Garacharama have been created.

3. **4TPD Coconut Waste Shredding and Co-Composting Facility at Brookshabad:**

A specialized facility with a 4-tonnes-per-day (TPD) capacity has been established at Brookshabad for the shredding and co-composting of coconut waste. This unit processes bulky and fibrous coconut husks and shells, which are otherwise difficult to degrade naturally.

4. **A Fish waste processing unit** has been set up at Junglighat to manage the high volume of organic waste generated from fish markets and related activities.
5. 26 SWM Cluster equipped with Bailing Machine and Shredding machine mapped to 70 GPs for processing of dry waste and all cluster having compost pits for wet waste processing by Vermi-composting method (among which 25 SWM Clusters are functional and 01 SWM Cluster is under construction with 55% of work is completed).
6. The Chief Secretary, A&N Administration vide Order dated 18.06.2024. has **constituted 12 teams of Senior Officers to inspect all existing Solid Waste Management facilities in SVPMC Area** i.e. DRCs, Landfill site and suggest various measures to improve their efficiency. The teams were also directed to inspect door to door collection mechanism and to identify vulnerable points where the garbage is dumped by the general public. **The compiled information reviews are done on a weekly basis by Chief Secretary, ANI** and stringent actions are taken against the violators.
7. **SVPMC has established an extensive system to weigh and monitor all waste generated in the city**, including private waste collection system. This process involves multiple weighment locations, with cross-verification at the Brookshabad check post to ensure accuracy. A digital waste generation data sheet is maintained for transparency and analysis.
8. A state of the art of **5 TPD Material Recovery Facility at Brookshabad for dry waste** with German technology with the help of GIZ has been installed Rs. 1.5Cr. on 23rd July, 2024. The plant is converting **the dry waste into shredded plastic** which is being sold to Public Works Department (PWD) for laying of roads. The same plant has a facility of **3 TPD glass pre-processing (shredding) unit**.
9. A manual paper recycling unit with a capacity of 0.1TPD is set to be installed with the support of GIZ-India. Procurement process has been completed; installation will be completed by the end of August 2025. This unit will enable the efficient recycling of wastepaper, transforming it into reusable office products and enhancing waste minimization and resource optimization within the council's operations.
10. Currently, SVPMC is distributing whatever compost made out of organic waste and coco- peat is being supplied to all the Government departments, schools and SVPMC's parks and green patches.
11. Sri Vijaya Puram Municipal Council Solid Waste (Handling and Management) Bye Laws, 2017 to regulate waste management in Sri Vijaya Puram city is notified in the Gazette of A&N Island. The SVPMC is empowered to take all

necessary steps to ensure proper management and treatment of waste and impose penalties and fines upon defaulting units.

12. The Andaman & Nicobar Islands Rural Areas Solid Waste Handling & Management Bye Laws, 2019 is notified by the Directorate of RD, PRI and ULB and have provisions to collect spot fines and charges from violators under the Bye Laws.
13. SVPMMC has introduced a web portal based,(accessible through the e-Nagar Sewa portal at pbmc.gov.in),dedicated to receiving and addressing public complaints and grievances related to sanitation and solid waste management issues in the city.

Minimal quantities of C&D waste are being generated in rural areas and these are used for maintenance of Path holes.

- **Total no. of wards, no. of wards having door to door collection service, no. of wards practicing segregation at source:**  
24 municipal wards and 70 Gram Panchayat having **100% door to door collection** with segregation at source.

- **Details of SW treatment facilities proposed and under construction (no., capacity, and technology):**  
**MRF facility of capacity 5 MTPD is established in Brookshabad in Sri Vijaya Puram City** to process recyclable waste such as coconut, glass, plastic, cardboard, and Multi-layered plastic (MLP). Plastic agglomeration unit, Coconut shredding machine and glass shredding machines have been installed in Dry Resource Material Recovery facility in Brookshabad ,this facility is supported by GIZ-India.

In order to meet & cater the future waste management demand i.e., for next 15years, keeping in view of expansion/ delimitation of jurisdiction of urban areas/ Sri Vijaya Puram city, proposal was submitted and approved for an integrated/ centralised 30 TPD capacity Municipal Solid Waste Processing, Treatment, and Management Facility for Dry and Wet waste at the Brookshabad site for Sri Vijaya Puram

Municipal Council. The tender was floated, the technical bid has been opened & finalized. The tendering process and award of contract will be expected by the end of May, 2025.

- **Action plan to bridge gap between Installed Capacity and Current Utilization of processing facilities (if Gap > 20%)::**

Situational Analysis and City Action Plan for Sri Vijaya Puram City For Support for Management of Organic Waste under Project MOWI of GIZ-India is being undertaken.

#### **VI. Plastic Waste Management:**

- As per the Annual Report on implementation of Plastic waste Management Rules 2016 (as amended), for the year 2022-23, Total Plastic Waste generation: 438MT of plastic waste from 01 Municipal Council and 250MT of plastic waste from Gram Panchayats.
- Treatment/ Measures adopted for reduction or management of plastic waste: 22 SWM Clusters catering to 24 municipal wards. Further 3-R principle is used. The waste is segregated and bailed for its transportation to mainland for recycling/scientific disposal. The waste in rural areas is managed in 24 clusters for all 70 Gram panchayats.
- A scheme has been made effective wherein it is mandatory to use 8-10% of the plastic waste is to be used for construction of roads by the implementing agencies/departments such as RD&P, SVPMC and APWD. Till date, 148.6075 MT of shredded plastic waste was utilized for construction of 162.1487 Km Road.
- A& N Administration has imposed complete ban of manufacture, storage, use, import, transportation, distribution and sale of single use plastic items in A&N Islands viz. PET Bottles- Water & Beverages, including alcohol, <15 mL (or equivalent in weight) and single use, plastic bodied use & throw pens in A&N Island, Notified in vide No.186 dated 05.09.2019.
- A& N Administration has imposed complete ban in use, manufacture and sale of plastic carry bags irrespective of its thickness, size, color and nature in A&N Islands vide Notification No.225 dated 24.09.2019

- A & N Administration issued directions vide Order No.210 dated 19.05.2020 to use alternatives such as cloth banners, light weight textile fabrics, natural fiber-based sandwich boards, etc. in various government functions, seminars, workshops, advertisements etc. to eliminate use of single use or short life PVC (Poly Vinyl Chloride) for flags & banners.
- Inspections were conducted jointly by ANPCC and SVPMC in Market areas of Sri Vijaya puram areas to enforce the ban on single-use plastic items. A total fine of Rs. 5000/- was imposed by SVPMC on the defaulters.

**Details of Alternate Treatment Technology** being adopted by the State/UT: MRF facility of capacity 5 MTPD is established in Brookshabad in Sri Vijaya Puram City to process recyclable waste such as coconut, glass, plastic, cardboard, and Multi-layered plastic (MLP). Plastic agglomeration unit, Coconut shredding machine and glass shredding machines have been installed in Dry Resource Material Recovery facility in Brookshabad, facility is supported by GIZ-India.

**No drains falling into rivers.** There are 6 rivers in the island in which 5 rivers are exclusively flowing through forest areas. 1 river flows partially through forests and partially through inhabited areas. The water quality was analyzed and it was found well within the permissible limits.

**IX. Details of meetings carried under the Chairmanship Chief of Secretary in the State/UT:**

- Meetings were held on 15-09-2023, 31-10-2023 under the Chairmanship of Chief Secretary ANI to review Solid Waste Management focusing on Waste segregation, collection, Transportation, disposal.
- The Chief Secretary, A&N Administration vide Order dated 18.06.2024 has constituted **12 teams of Senior Officers to inspect all existing Solid Waste Management facilities in SVPMC Area** i.e. DRCs, Landfill site and suggest various measures to improve their efficiency. The teams were also directed to inspect door to door collection mechanism and to identify vulnerable points where the garbage is dumped by the general public. **The compiled information reviews on a weekly basis are done by Chief Secretary, ANI and stringent actions are taken against the violators.**
- 11 State Level Advisory Committee (SLAC) meetings conducted under the Chairmanship of the Chief Secretary.

**X. Latest water quality of polluted river, its tributaries, drains with flow details and ground water quality in the catchment of polluted river:**

There are 6 rivers in the island in which 5 rivers are exclusively flowing through forest areas. 1 river flows partially through forests and partially through inhabited areas. The water quality was analyzed and it was found well within the permissible limits.

**XI. Ground water regulation:**

- The Central Ground Water Board, Eastern Region, Kolkata conducted a meeting under the Chairmanship of Deputy Commissioner, South Andaman on 07-10-2021 to discuss Ground water Extraction Rules, Regulations and the procedure for implementation of guidelines to regulate and control groundwater extraction in India as per notification of Ministry of Jal Shakti, notified vide S.O. 3289(E), dt.24th September, 2020.
- In order to maintain uniformity among all SPCBs/PCCs w.r.t issuance of Consent to Establish (CTE)/ Consent to Operate (CTO) in relation to ground water NOC the requirement for submission of a No Objection Certificate (NOC) from CGWA regarding the usage of groundwater during the consent application process has been eliminated. Henceforth, in case of usage of ground water, the project proponent must obtain NOC from CGWA within one month from the date of issue of CTE/CTO/CA unless falling in exempted category as per MoJS guidelines dated 24-09-2020 and amendments dated 29-03-2024 thereto.

**XII. Good irrigation practices being adopted by the State:**

**Large Scale irrigation is not practices in Andaman & Nicobar Islands** due to receipt of rainfall throughout the year.

**XIII. Rain Water Harvesting:**

- SVPMC incorporated Rain water harvesting as a mandatory part while applying for Building Plan approval.
- Construction of 10 MLD water treatment plant and two Clear water Reservoirs at Garacharma, Sri Vijaya Puram is in progress.
- In case of Rural Areas, 160 No of building identified for Rain water harvesting in the year 2022-23 where in 33 building rain water harvesting is installed and completed.

**XIV. Demarcation of Floodplain and removal of illegal encroachments:** No floodplains existing in A&NI.

**XV. Maintaining minimum e-flow of river:** NA

**XVI. Plantation activities along the rivers:**

There are 6 rivers in the island in which 5 rivers are exclusively **flowing through forest areas**. 1 river flows partially through forests and partially through inhabited areas (rural areas).

**XVII. Development of Biodiversity Park:**

- The A&N Islands is rich in natural forest wealth and biodiversity. **Nearly 85% of the area of the island is covered under natural vegetation.** For the in-situ conservation of biodiversity of the islands, 6 National Parks and 96 WLS have been constituted. For ex-situ conservation and education and awareness, 1 Biological Park has been created. Further, for education and awareness for the urban mass and tourists, one Nature Park-cum-Interpretation Center has been opened in the city.
- Further SVPMC vide letter No. 41/EE-III/SWM/MC/2018-19/89 dated 16-08-2021 has informed that a committee has been constituted for Biodiversity management as per the Hon'ble NGT direction and formulated & submitted the People's Biodiversity Register(PBR) for the Sri Vijaya Puram City on 24-06-2021.SVPMC have developed 25 Parks & gardens, 32.7 Hectares approx.

**XVIII. Reuse of Treated Water:**

The treated water from STPs installed in various industries are used for **Gardening & Toilets flushing purposes**.

**XIX. Model River being adopted by the State & Action Proposed for achieving the bathing quality standards:** No river adopted in the Islands.

**XX. Status of Preparation of Action Plan by the 13 Coastal States:**

The River Rejuvenation Committee constituted vide Order no. 3374 dated 29.10.18 has been renamed and reconstituted as 'River/Coastal Rejuvenation Committee' vide Order no. 442 dated 16.02.21 by incorporating subject officers/experts from other concerned departments of the A&N Administration. The 1<sup>st</sup> meeting of the River/Coastal Rejuvenation Committee was held on 25.03.21. The Deputy Commissioner (North & Middle Andaman District) constituted a district level committee vide Order no. 39 dated 20.04.21 and held its meeting on 21.04.21. The Deputy Commissioner (Nicobar District) constituted a district level committee vide Order no. 516 dated 25.03.21. The Deputy Commissioner (South Andaman District) constituted a district level committee vide Order no. 267 dated 06-08-21. The 2<sup>nd</sup> meeting of the River/Coastal Rejuvenation Committee was held on 29-07-21. Proposed action plan for South Andaman(SA) District has been submitted by DC SA on 25-08-2021.Proposed action plan for North & Middle Andaman(NMA) district has been submitted by DC(NMA) on 23-06-2022.Proposed action plan for Nicobar District has been submitted by DC(Nicobar) on 05-07-2022.Compilation of the

River/Coastal Rejuvenation Plan is under process. Third meeting of River Rejuvenation/ Coastal Rejuvenation committee was held on 06.09.2023 at 4.00Pm in which all the three districts submitted the Coastal action plan to the committee and the coastal action plan for South Andaman District, North and Middle Andaman District and Nicobar District were finalized by the committee. **The finalized coastal action plan has been submitted to CPCB vide letter No.2-16/PCC/PWM(2016)/2023/749 dated 10.11.2023.**

**XXI. Regulation of Mining Activities in the State/UT:**

The Deputy Commissioner (South Andaman District), The Deputy Commissioner (North & Middle Andaman District) and The Deputy Commissioner (Nicobar District) regulate mining activities in the UT of ANI. The sand mining in coastal areas (sea sand) is being regulated by Department of Environment & Forest, A&N Islands. There is a separate authority for management of coastal areas of the island namely Andaman & Nicobar Coastal Zone Management Authority (ANCZMA) which also looks into matters related with sand mining in the coastal areas of the islands.

**XXII. Action against identified polluters, law violators and officers responsible for failure for vigorous monitoring:**

Since 5 out of the 6 rivers in the islands flows exclusively through forests, **no pollution reported.** Further, the 6<sup>th</sup> river flows partially through forest and habituated areas (rural). No polluting industry or units exists.
