The Govt. of India has received financing for an amount of US\$ 1 Billion equivalent from the World Bank toward the cost of the **National Ganga River Basin Project (NGRBP)**, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project.

The project will have two components relating to institutional development and priority infrastructure investments. The first component would seek to build the institutional capacity to effectively implement the overall NGRBA program, including infrastructure investments funded by the second component. The project aims that the National Ganga River Basin Authority (NGRBA): builds capacity of its operational-level institutions for managing a comprehensive Ganga clean-up and conservation program; and reduces point-source pollution loads through sustainable interventions at selected locations on the Ganga. Various goods and services identified to be procured through ICB procedures include:

- 35 nos. Sewage Treatment Plants in 5 states i.e Uttarakhand, UP, Bihar, Jharkhand and West Bengal with capacity ranging from 2 Mld to 200 Mld with 10yrs. O&M and on DBOT basis. Some of the Sewage Treatment Plants will also be with Sewage Network.
- River Front Development in 5 states i.e Uttarakhand, UP, Bihar, Jharkhand and West Bengal
- Services to provide real-time information for water quality parameters at selected locations in the Ganga system;
- Procurement of Laboratory Equipment (Laboratory Safety, Processing, and Preservation Systems) for Pollution Control Boards at national level and in 5 states;
- Procurement of Laboratory Instrumentation Equipment for Pollution Control Boards at national level and in 5 states;
- Procurement of IT Equipment (IT hardware, GIS software, computers, laptops, servers) for national level and in 5 states.

- Procurement of Cameras, LCD/DLP Projectors for national level and in 5 states
- Consultancy Services to support Ganga Knowledge Base Development, Modeling, and Use
- Consultancy services for the Central Pollution Control Board to conduct a Ganga Water Pollution Source Inventory
- Consultancy services to conduct a Strategic Environmental, Social, and Economic Assessment for the Ganga Basin
- Consultancy services for the National Ganga River Basin Authority to facilitate Program Communications and Community Participation (including city-level strategy and intermediation services);
- Consultancy services for the Central Pollution Control Board to provide Quality Assurance for the real-time water quality monitoring system performance;
- Consultancy services for the Central Pollution Control Board to undertake a Biomonitoring assessment for the Ganga;
- Consultancy services to develop Systems for Governance and Accountability Action Plan (including e-procurement and grievance redressal) for the National Ganga River Basin Authority
- Works related to Sewage Treatment Plant, Network and Combined Sewage Treatment Plant and Network with 10/15 yrs. O&M and on DBOT basis for all the 5 States along river Ganga.
- Works related to River Front Development for all the 5 States along river Ganga.
- Works related to Effluent Treatment Plant for all the 5 States along river Ganga.

Procurement of goods & works, financed by the World Bank will be conducted through the procedures as specified in the World Bank's [Guidelines: Procurement under IBRD Loans and IDA Credits](#) (2012 edition), and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the World Bank's [Guidelines: Selection and Employment of Consultants by World Bank Borrowers](#) (2012 edition).

Specific procurement notices for goods, works and consultancy services contracts, to be bid under the World Bank's international competitive bidding (ICB) procedures will be announced, as they become available, on the Bank's external website and in national/local newspapers.
