**Notice regarding engagements of Young Professionals for Arth Ganga Cell in National Mission for Clean Ganga (NMCG), New Delhi**

Applications are invited from willing and eligible Young Professionals for engagement on contract basis on fixed remuneration for a period of one year, initially, from the date of engagement which may be extended as per the functional need.

**1. Engagements of Young Professionals in the National Mission for Clean Ganga (NMCG), New Delhi**

National Mission for Clean Ganga (NMCG), proposes to engage **2 (Two) Young Professionals** in New Delhi for achieving its objectives:

1. The Terms and Conditions, the eligibility criteria etc., for engaging the Professionals shall be as under:

1.1 **Categories to be engaged:** Young Professionals

1.2 **Target group:** The candidates as per the prescribed "eligibility" at Annexure A.

1.3 **Objectives:** To achieve the objectives of NMCG as per Authorities Order dated 7<sup>th</sup> October, 2016 in a time bound manner.

1.4 **Eligibility:** Interested candidates, who are citizens of India and fulfilling the eligibility criteria (education qualification & experience) at Annexure 'A'.

1.4.1 **Age:** Candidate must be less than 35 years

1.5 **Duration of the Engagement:** The initial term of appointment shall be for a period of one year from date of engagement and subsequent extension(s) if any, shall be decided on case-to-case basis depending upon requirement and performance.

The appointment of professionals would be on Full-time basis and they would not be permitted to take up any other assignment during the period of engagement with the NMCG.

1.6 **Number of vacancies:** Young Professionals – 2

1.7 **Declaration of Secrecy:** All professionals engaged will be required



to furnish oath of secrecy in prescribed format at the time of reporting for the engagement.

During the period of assignment with NMCG, the professionals would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by him/her during the period of engagement to anyone who is not authorized to know/have the same.

The professionals engaged by the NMCG shall in no case represent or give opinion or advice to others in any manner which is adverse to the interest of NMCG.

1.8 All other terms and conditions of engagement will be as per rules and regulations of concerned States.

**1.9. Termination Notice:**

NMCG can cancel the appointment of a consultant at any time without providing any reason for it. However, in the normal course, one month's notice shall be given to the Consultant. The Professionals may also seek termination of the Contract upon giving one month's notice to NMCG.

**1.10 Application and Selection:**

1.10.1 Method of application – Submission of online application with CV as per the advertisement of the NMCG.

1.10.2 All the received applications are short listed based on requisite eligibility will be called for personal interview on a specified date.

1.10.3 The selection shall be made on the basis of recommendations of Selection Committee constituted for the purpose by the NMCG.

1.10.4 The candidate will be required to produce original certificates in support of fulfilling the eligibility criteria, etc., as to educational qualification and experience during interview and at the time of joining.

**Note:** No TA/DA will be provided for attending the interview/joining, irrespective of selection.

**ANNEXURE -A**

**Name of the Position: Young Professionals**

No. of Positions – two (2) nos.

Desired Skills :

- Young Professionals will be engaged in providing high-quality services on different interventions of Arth Ganga.
- Professionals with requisite qualifications and experience as prescribed would be hired as Young professionals.
- The initial tenure of engagement for a person as a Young professional would be on a year-to-year basis. The extension will be performance-based.
- After the appointment, the Young professionals will not be allowed to take up any other assignment during the period of engagement with the NMCG
